# Boater Safety Class set for June 14

It doesn't seem possible, but this is the 8th annual Boater Safety Class that our association will sponsor, this year on Saturday, June 14, at the Webster Library in downtown Decatur from 8 a.m. to 3:30 p.m.

This is an excellent course for those purchasing a new boat or who have never taken a boating safety course and learned the simple rules of the waterways and safe boat operations.

We are pleased to cooperate with the Van Buren County Sheriff and the Michigan Department of Natural Resources in bringing this program to our members.

Pre-registration is RE-QUIRED by calling 269-423-8810 by June 7. Give your name, address, age, date of birth and telephone number.

Participants are to bring a sack lunch, note paper and a pencil or pen. Refreshments will be provided by the Association.

Michigan law states,
"Boaters born after December 31, 1978 are required to have a valid Boaters Safety Certificate to
operate a personal water-

craft (PWC) on Michigan Waterways."

Course participants must be at lease 12 years of age. If a person 12 or more AND his/her parent or legal guardian have obtained a boating safety certificate, special PWC regulations apply.

The Association also encourages adult participation to brush up on the latest boating rules and regulations.

There is no charge for the course, and successful students will be awarded a Michigan Boaters Safety Certificate at the conclusion of the class.

## Docks carry riparian rights and legal responsibilities

When they put their dock in the water during the spring, most riparians do not think of all the legal implications regarding the dock and its location. Interestingly, there actually are many factors regarding a dock which could land its owner in court, although that rarely happens.

A dock can normally rest only on the bottomlands of the person who owns the dock. In Michigan, a riparian property owner on an inland lake normally owns the bottomlands adjacent to his/her lakefront property. Those bottomlands typically radiate to the center of the lake, although it is often difficult to determine what constitutes the center of the lake with irregularly-shaped lakes.

Rarely do riparian or bottomlands boundary lines radiate to the center of the lake at the same angle as the side lot lines that exist on dry land.

Determining where riparian/ bottomlands boundaries are located under the water for purposes of dock placement can often be a difficult task, particularly where relatively small lakefront properties are involved and property owners try to crowd the outer edge of their bottomlands with dockage.

Dock regulations can be found in municipal zoning ordinances or even in standalone police power ordinances. Violation of such an ordinance can constitute either a criminal misdemeanor or a municipal civil infraction offense, depending upon the penalties provision of the ordinance involved.

The use of a dock by more than one family will typically trigger both state and local regulations. At the state

Follow a few steps to save money on boat fuel without making any drastic changes to your boating lifestyle.

- Clean the bottom of your boat. (Reduces friction, saves fuel.)
- 2. Remove excess weight from your boat. (Causes 2% mpg reduction.)
- 3. Change the oil and replace the air filter. (Increases fuel-efficiency)
- 4. Ease on the acceleration and avoid idling. (Why waste fuel?)
- 5. Try fuel additives. (Some are

- 6. Buy your fuel in the morning hours. (Gas is considered to be denser with less heat in the air.)
- 7. Consider investing in a fuel meter or computer. (Gives you instant visual feedback on exactly how much fuel you are burning, allowing real-time adjustments to impact fuel use efficiency.)

The property owners in this area are planning to have the waters chemically treated to control lake weeds and/or algae. This notice is being circulated in accordance with Department of Environmental Quality (DEQ) procedures. A permit for the treatment has either been secured or will be secured from the DEQ before the work is begun.

We treat each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board or residents on the lake. Due to the uncertainty of weather, the treatment schedule is approximate. Please watch your shoreline for the posting of the 11 x 14 inch, yellow, red or green signs. The signs will indicate the date of the treatment, the products used, and any restrictions on the use of treated water for swimming, watering lawns, etc.. One or more treatments involving water restrictive products may be applied. There may be spot treating of vegetation involving water restrictive products throughout the summer.

In the event that you see us spraying for algae control with copper based products, signs may be posted stating there is no restrictions. The purpose of this requirement by the DEQ is to let you know that we treated your waters and there are no restrictions. The signs used for algae treatments will be "Green" and the signs for restrictive products will be "Yellow" or "Red". Please be aware that only products approved by the State of Michigan and the Federal government are being used. We have experienced *no adverse effects on people, fish, wildlife or domestic pets since applying these products.* We anticipate using one or more of the products listed below. Please read the restrictions. Again, the restrictions that apply to the products actually used in a particular treatment will be found on the signs posted on the day of treatment.

When more than one product is used, the most strict, longest limits will be posted. These restrictions are designed to allow for the safe use of these products. Please do not encourage anyone to use the waters while these restrictions apply.

If you have any questions please contact us during office hours. (8:00 am 4:00 pm M-F)

level, the MDEQ has taken the position that any dock utilized by more than one family can constitute a "marina" for which a state permit must be obtained from DEQ. At the local level, use of a dock by more than one family is generally considered a multi-family use which is only allowed in certain zoning districts.

The presence of a dock raises potential issues of liability. People can get hurt diving off a dock, running into docks with boats, or having some other dock-related calamity occur. Accordingly, it is very important for the riparian property owner to carry

adequate liability insurance for the lakefront property which expressly includes coverage for the dock (as well as any other structures such as shore stations, floating rafts and boats). Given the litigious society in which we live today, liability limits of \$300,000 or even \$500,000 could very well prove inadequate.

What if there is no local ordinance in your jurisdiction which limits dock length and the DNR chooses not to act regarding the length of a particular dock? Can a riparian install a dock as far out into the lake as he/she wishes, so long as it is located en-

Assuming that no state or local enforcement action occurs, an unreasonably long dock could still violate the common law doctrine of riparian rights. Pursuant to that doctrine, a neighbor or nearby riparian can sue another lakefront property owner if the offending party does anything on or at the water which unreasonably interferes with the reasonable lake usage rights of the nearby or neighboring riparian.



Residents are reminded that *native* weeds are healthy for the ecosystem. They are good for the fish and the water.

After evaluating any problem area, PLM and the Association Board will determine if the weeds are exotic or native and whether additional treatment and/or harvesting is warranted.

When all residents monitor the lake, we work together to control the weeds and maintain the highest possible water quality.
